- Minutes were reviewed and noted corrections needed are:
  - o Added Dan Gatlin being present at last meeting
- Motion was made by Misty Quandt and seconded by Betty Proctor. All present approved.

Reports:

- President:
  - o NW tournament recap
    - 85 teams of 5 which equals 425 bowlers
    - 275 singles entries
    - 135 doubles entries
    - Total prize fund will be \$14,306
  - o Next year for NW tournament
    - Tournament will be held in Tallahassee
      - Looking to hold the tournament on 2/4/2017 & 2/11/2017 for the team event. Will change to only be a 4 person team instead of 5.
      - Singles and doubles will be on 2/5/2017 & 2/12/2017
      - Lineage will be \$10/person
      - Deadline for entries will be 1/21/2017. No walk-ins allowed
    - We will really need to focus on this tournament and try to exceed the amount of entries for this year and prior years.
    - Constitution and bylaws to be reworked over the summer so changes can be voted in by September 2016. Michael would like Dan to arrange with the Panama City Association a meeting in September for the 17<sup>th</sup> or 24<sup>th</sup> of that month.
    - This is an invitational so entry forms can be sent out all over Florida and possibly Georgia.
  - o 5 year plan
    - We need to focus on changing things from the normal, daily routine.
    - We need to work on moving bowlers from our Fun leagues to actually becoming members of USBC.
    - Currently there are about 545 members. We should have a goal of increasing our membership by 10% each year. A good push toward this goal is to follow Buster example and have a non sanctioned league over the summer.
    - Find ways to get the word out to current bowlers and perspective bowlers. Let's look at trying to get the information in the Tallahassee Democrat.

- Control our expenses and find ways to give back to the bowlers. We do not have a limitation on the awards we could offer. Betty Proctor and Anthony Williams volunteered to work with Mike to create an award process. We may want to also consider getting sponsorships for our tournaments to help add money to the prize fund.
