Guidelines for Hall of Fame Induction

The purpose of the Hall of Fame is to perpetuate the names of those who have displayed outstanding ability in the sport of American Tenpins and/or have contributed meritorious service to the reputation and progress of bowling in the area served by the Tallahassee USBC Association.

Any member of TUSBC Association may submit nominations, along with the nominee's qualifications and achievements to the Association President or Association Manager. These qualifications will be verified by the Association Manager and reviewed by the Hall of Fame committee.

Nominees may be made for living or deceased members.

No more than <u>4</u> bowling achievement (2 men & 2 women) and <u>2</u> meritorious nominees will be inducted per year.

Candidate Qualifications:

A nominee must accumulate **50** or more points to qualify for induction into the Tallahassee USBC Hall of Fame. **Nominators need to provide documentation to justify points.**
