### OTHERS IN ATTENDANCE:

A motion by Stephon Williams to approve the minutes for the October 25, 2025 board meeting was approved by all. Motion was seconded by Demitrius Hargrett.

### OFFICERS' REPORTS:

President Michael Fleischacker reported:

- Seminole Lanes has 16 of 18 lanes working. They will contact USBC once they have all lanes working to get them certified. They hope to be open by the beginning of the year.
- During the president's remarks, Stephon Williams submitted his resignation to the board. There was discussion as to how to fill the vacant position. Laurie Davis and Gerry Martin were names brought forward in the meeting. Demitrius suggested that we wait to see if any other people are interested. Michael will send out an email for the board to vote on a replacement next week.

### ASSOCIATION MANAGER:

USBC does not require January 1<sup>st</sup> averages. The board would like a change to the P&P to require league secretaries to submit January 1 averages to the association manager. The averages are used for tournaments.

- Tournament:
  - BVL Report.
    - 68 bowlers - \$4822.00 raised
  - EOY Tournament – Tentative date has been set for March 6-8, 2026
    - Have to offer a women's tournament to satisfy the USBC requirement.
    - Still deciding on the format
      - Will not be open to out of association bowlers.
      - Average will be as of January 1 with 21 games or currently bowling in a Tallahassee league without 21 games.
      - Will allow multiple entries. Will only be paid once.
    - A motion by Helen Leon to add \$3000 to the prize fund was approved by all. Motion was seconded by Mimi Hamrick.
- Hall of Fame: Changes have been made. LaQuita will send out the form to the league secretaries after the holiday break.
- Nominating: The committee will have everything out by the end of January.
- Policy & Procedures: The committee will meet before the next meeting and bring the changes to the board for approval. Some changes include
  - Meal Reimbursement increase
  - Lodging reimbursement increase
  - Operating expense amount
  - January 1 averages being submitted by leagues
- Youth: Three bowlers qualified for JR Gold at the Landon Tournament. Tallahassee Youth will host another JR Gold qualifier on February 15, 2026 at FSU.
